- (3) Threshold in the Japan-Singapore Economic Agreement for a New Age Partnership From November 30, 2002, on which the Agreement entered into force, the threshold for the procurement of goods and services by the central government, public corporations and independent administrative institutions became lowered to SDR 100,000 (17 million yen).
