Understanding among related ministries and agencies concerned in procurement

- 1. Based on the Operational Guideline on Procedures for Government Procurement (Understanding among related ministries and agencies concerned in procurement, 31 March 2014) 16., Measures on Japanese Public Sector Procurement of Telecommunications Products and Services (Understanding among related ministries and agencies concerned in procurement, 31 March 2014) VII., and Measures related to Japanese Public Sector Procurement of Medical Technology Products and Services (Understanding among related ministries and agencies concerned in procurement, 31 March 2014) IX., a Meeting of Related Ministries and Agencies Concerning Voluntary Measures on Government Procurement (hereinafter "Voluntary Review Meeting") shall be convened in order to conduct review and follow-up relating to these understandings among related ministries and agencies.
- 2. The composition of the Voluntary Review Meeting shall be as described hereunder. However, should it be deemed necessary by the Chair, it shall be possible to increase the membership of the meeting.
