Operational Guideline on Procedures for Government Procurement etc.

(Understanding among related ministries and agencies concerned in procurement)

1. In accordance with the provisions of the Protocol Amending the Agreement on Government Procurement (hereinafter the "Amendment Protocol"), done in Geneva on 30 March 2012 and by which the Agreement on Government Procurement, done in Marrakesh on 15 April 1994, was amended, the following Attachments from 1 to 6 as detailed in the table below are stipulated.
